

TERMS AND CONDITIONS

Taste of Auckland in partnership with Electrolux and Cuisine "Icon Dish" competition

As at 11 October 2017

1. Eligibility

- a. The competition is open to New Zealand residents aged 18 years or over.
- b. Staff and families of Lemongrass Productions, Cuisine and its subsidiaries, and anyone associated with the competition are not eligible to enter. Lemongrass Productions reserves the right to verify the eligibility of entrants. The entry is not transferable. The demise of an entrant disqualifies his/her entry.
- c. The entry must be received by Lemongrass Productions during the relevant competition period. Proof of submission does not constitute proof of receipt of the entry. Lemongrass Productions accepts no responsibility for any late, lost or misdirected entries, including entries not received or delays in the delivery of the entries due to technical disruptions, network congestion, or any combination thereof or for any other reason.
- d. Lemongrass Productions reserves the right to exclude any entrants which it deems to be violating any of the terms and conditions stated herein.

2. Competition Period

The competition is open 12 Oct-9 Nov 2017.

3. How to Enter

To be eligible for the prize, each participant must visit tasteofauckland/icondish, select the dish they want to vote for and share their entry onto Facebook. All email addresses entered will be collected and held by Lemongrass Productions in accordance with these terms and conditions. Entrants may submit multiple entries for the competition.

4. The Prize

- a. The Prize comprises of: a taste of the winning dish, Qantas VIP tickets for 2 adults to Taste of Auckland in partnership with Electrolux, return flights from any New Zealand domestic airport to Auckland, 1-nights' accommodation at Hilton Auckland including breakfast, return airport to hotel transfers in Auckland, and return transfers to/from Taste of Auckland festival on the 18th November.
- b. Entry to Taste of Auckland presented by Electrolux is for Saturday 18 November 12:00pm-4:00pm only.
